Gemma Adaba is the Representative of the International Confederation of Free Trade Unions (ICFTU) to the United Nations in New York, a Confederation of national trade union centres in 152 countries and territories on all five continents, with a total membership of 148 million workers. A native of Trinidad and Tobago, Ms. Adaba is a passionate advocate for decent work, social justice and gender equality; she serves on the board of the North-South Centre and on the jury for the ILO Decent Work Prize. Her trade union work began in the teaching sector, where she was an active member of the Trinidad and Tobago Teachers Association in the late 1960s. She obtained a Masters' Degree in Sociology from the University of Western Ontario, Canada, and pursued post-graduate research in Sociology and Demography at the Free University of Brussels in Belgium.

Dr. Myrna Cunningham, a surgeon, is Chair of the Center for Indigenous People's Autonomy and Development and also the founder of Casa Museo, a museum and multicultural center dedicated to indigenous and Afro-Nicaraguan art and history. Dr. Cunningham is an indigenous Miskita and a former member of the National Assembly of Nicaragua where she also served as Minister of Health and as Governor of the North Atlantic Coast. She founded (and acted as the first female Chancellor of) the University of the Autonomous Regions of the Caribbean Coast of Nicaragua (URACCAN) and has served as the General Secretary of the Inter-American Indigenous Institute. In 2002, she received the Pan American Health Organization's Public Health Heroine of the Americas Award.

Joseph Cornelius Donnelly serves as Permanent Delegate to the United Nations for Caritas Internationalis, a global confederation of 162 Catholic relief, development and social services organizations with programs in more than 200 countries and territories. As the Caritas representative to the UN, Donnelly has developed working groups with both secular and faith-based NGOs to highlight particular needs of countries and peoples caught in crises, both those well-covered by the media and those "hidden crises" with equally profound destruction of life,

land, human rights and basic hopes. Some of these are focused on Northern Uganda, Haiti, Democratic Republic of Congo, Colombia, Sri Lanka, Southeast Asia and Iraq.

Mr. Donnelly has, in particular, worked on Middle East issues for the last two decades, during many years of which he lived in the region and worked to build partnerships in diverse efforts with governments, civil society, religious leaders and the international community. His involvement with and on behalf of Iraqi refugees began in 1991 with the urgent humanitarian needs that followed the first Gulf War. He has continued to the present day working with Caritas programs, NGO partners and U.N. colleagues in the region while advocating at UN Headquarters with Member States and the UN Security Council.

Elisabeth Gateau is the first Secretary General of UCLG. Building on her past experience as a local elected official in France, she previously held the position of Secretary General of the Council of European Municipalities and Regions (CEMR), the European section of UCLG. She then went on to oversee local government issues at the Secretariat of the European Convention, which prepared the draft Constitution of the European Union. In July 2004, Elisabeth Gateau's longstanding contribution to regional and local politics received special recognition through the Emperor Maximilian Prize award that acknowledges the outstanding efforts made to implement the principle of subsidiarity and the Council of Europe's Charter on Local Self-Government. Ms. Gateau has dedicated her first and second terms as Secretary General to setting the basis for a strong UCLG by: increasing the role and influence of local government in global governance and making UCLG the main source of support for democratic, effective, innovative local government close to the citizen.

It has worked since its formation in 1992 to affect a harmonized agenda for third sector development and its influence in the national framework. In the early 1990s, Ms Ransome-Kuti established 'Girl Watch'; an organization aimed at educating young Nigerian girls from poor backgrounds. In 2006, she was appointed a Civil Society advisor to the World Bank. Ms Ransome-Kuti has been one of those leading the charge in working for Nigeria to meet its Millennium Development Goals and to eradicate poverty.
