### 1. General information:

Post title: Expert in designing participatory methodologies for evaluating aid flows

(Consultancy)

**Duration**: one month (full time consultancy)

Date required: 1 July 2010

**Duty station:** Home based

Payment: Consultants are requested to submit a technical and financial proposal for their work

in this consultancy.

In the evaluation of candidacies the weight given to the technical and financial proposals is 49% and 51% respectively.

In order to be able to evaluate the technical offer, the panel will take into consideration:

- Methodology of work
- Working plan
- Feasibility to accomplish objectives and obtain results
- Previous work experience and knowledge, and education of the consultant.

#### 2. Supervision:

The consultant will be working under the direct supervision of the UN INSTRAW Aid Effectiveness Project Coordinator, in close collaboration with the Community of Practice Specialist and under the overall supervision of the Social Affairs Officer.

Content and methodology of the supervision: , the consultant will have periodic virtual meetings with the supervisor in order to assess progress and performance.

# 3. Objective of the Consultancy

Develop a participatory methodology for evaluating aid flows by civil society from a gender perspective in 6 different countries (Cambodia, Guatemala, Peru, Morocco, Mozambique, and Viet Nam).

- 1- Develop the concept, structure and methodology to be used in preparing participatory evaluation reports of aid flows in selected countries from a gender perspective
- 2- Develop an agenda for conducting the evaluation in the selected countries
- 3- Define and provide methodological materials and intervention tools to undertake the evaluation in the selected countries
- 4- Outline contents to be included in capacity-development process to ensure civil society capacity to evaluate aid flows with a gender perspective.
